

# FAO/BIOVERSITY MULTI-CROP PASSPORT DESCRIPTORS V.2

June 2012

This list of Multi-crop Passport Descriptors (MCPD V.2) is a revision of the original FAO/IPGRI publication released in 2001, expanded to accommodate emerging needs, such as the broader use of GPS tools, or the implementation of the International Treaty on Plant Genetic Resources for Food and Agriculture's Multilateral System for access and benefit-sharing. This MCPD V.2 list is an expansion of the first version of the MCPD, the descriptors and allowed values of the first version form a subset of those in this revision.

The 2001 list, developed jointly by Bioversity International (formerly IPGRI) and FAO, has been widely used and is considered the international standard to facilitate germplasm passport information exchange. These descriptors aim to be compatible with Bioversity's crop descriptor lists, with the descriptors used for the FAO World Information and Early Warning System (WIEWS) on plant genetic resources (PGR), and with the GENESYS global portal.

For each multi-crop passport descriptor, a brief explanation of content, coding scheme and, in parentheses, suggested fieldname are provided to assist in the computerized exchange of this type of data. Annex I provides easy access to the historical 'List of major changes' of all descriptor elements.

It is recognized that networks or groups of users may want to further expand this revised MCPD list to meet their specific needs. As long as these additions allow for an easy conversion to the format proposed in MCPD V.2, basic passport data can be exchanged worldwide in a consistent manner.

## ***Common formatting rules***

- (i) If a field allows multiple values, these values should be separated by a semicolon (;) without space (e.g. Accession name: Symphony;Emma;Songino).
- (ii) A field for which no value is available should be left empty (e.g. Elevation). If data are exchanged in ASCII format, a field with a missing numeric value should be left empty. If data are exchanged in a database format, missing numeric values should be represented by generic NULL values.
- (iii) Dates are recorded as YYYYMMDD. If the month or day are missing, this should be indicated with hyphens or '00' [double zero]. If both (month and day) are missing, two double zeros are needed (e.g. 1975----, 19750000; 197506--, 19750600).

- (iv) Country names: Three letter ISO codes are used for countries. The ISO 3166-1: Code List and the Country or the Country or area numerical codes added or changed are available online at: <http://unstats.un.org/unsd/methods/m49/m49alpha.htm>.

- (v) For institutes, the codes from FAO WIEWS should be used. The current set of Institute Codes is available from the FAO Web site (<http://apps3.fao.org/wiews/wiews.jsp>). From the Main Menu select: 'PGR' and 'Download'. ## MULTI-CROP PASSPORT DESCRIPTORS

<b>1.</b>	<b>Institute code</b>	<b>(INSTCODE)</b>
FAO WIEWS code of the institute where the accession is maintained. The codes consist of the 3-letter ISO 3166 country code of the country where the institute is located plus a number (e.g. COL001). The current set of institute codes is available from <a href="http://apps3.fao.org/wiews/wiews.jsp">http://apps3.fao.org/wiews/wiews.jsp</a> . For those institutes not yet having an FAO Code, or for those with 'obsolete' codes, see ' <i>Common formatting rules (v)</i> '.		
<b>2.</b>	<b>Accession number</b>	<b>(ACCENUMB)</b>
This is the unique identifier for accessions within a genebank, and is assigned when a sample is entered into the genebank collection (e.g. 'PI 113869').		
<b>3.</b>	<b>Collecting number</b>	<b>(COLLNUMB)</b>
Original identifier assigned by the collector(s) of the sample, normally composed of the name or initials of the collector(s) followed by a number (e.g. 'FM9909'). This identifier is essential for identifying duplicates held in different collections.		
<b>4.</b>	<b>Collecting institute code</b>	<b>(COLLCODE)</b>
FAO WIEWS code of the institute collecting the sample. If the holding institute has collected the material, the collecting institute code (COLLCODE) should be the same as the holding institute code (INSTCODE). Follows INSTCODE standard. Multiple values are separated by a semicolon without space.		
<b>4.1</b>	<b>Collecting institute name</b>	<b>(COLLNAME)</b>
Name of the institute collecting the sample. This descriptor should be used only if COLLCODE cannot be filled because the FAO WIEWS code for this institute is not available. Multiple values are separated by a semicolon without space		
<b>4.1.1</b>	<b>Collecting institute address</b>	<b>(COLLINSTADDRESS)</b>
Address of the institute collecting the sample. This descriptor should be used only if COLLCODE cannot be filled since the FAO WIEWS code for this institute is not available. Multiple values are separated by a semicolon without space.		

<b>4.2 Collecting mission identifier</b>	<b>(COLLMISSID)</b>
Identifier of the collecting mission used by the Collecting Institute (4 or 4.1) (e.g. 'CIATFOR-052', 'CN426').	
<b>5. Genus</b>	<b>(GENUS)</b>
Genus name for taxon. Initial uppercase letter required.	
<b>6. Species</b>	<b>(SPECIES)</b>
Specific epithet portion of the scientific name in lowercase letters. Only the following abbreviation is allowed: 'sp.'	
<b>7. Species authority</b>	<b>(SPAUTHOR)</b>
Provide the authority for the species name.	
<b>8. Subtaxon</b>	<b>(SUBTAXA)</b>
Subtaxon can be used to store any additional taxonomic identifier. The following abbreviations are allowed: 'subsp.' (for subspecies); 'convar.' (for convariety); 'var.' (for variety); 'f.' (for form); 'Group' (for 'cultivar group').	
<b>9. Subtaxon authority</b>	<b>(SUBTAUTHOR)</b>
Provide the subtaxon authority at the most detailed taxonomic level.	
<b>10. Common crop name</b>	<b>(CROPNAME)</b>
Common name of the crop. Example: 'malting barley', 'macadamia', 'maïs'.	
<b>11. Accession name</b>	<b>(ACCENAME)</b>
Either a registered or other designation given to the material received, other than the donor's accession number (23) or collecting number (3). First letter uppercase. Multiple names are separated by a semicolon without space. Example: Accession name: Bogatyr;Symphony;Emma.	
<b>12. Acquisition date [YYYYMMDD]</b>	<b>(ACQDATE)</b>
Date on which the accession entered the collection where YYYY is the year, MM is the month and DD is the day. Missing data (MM or DD) should be indicated with hyphens or '00' [double zero].	
<b>13. Country of origin</b>	<b>(ORIGCTY)</b>
3-letter ISO 3166-1 code of the country in which the sample was originally collected (e.g. landrace, crop wild relative, farmers' variety), bred or selected (breeding lines, GMOs, segregating populations, hybrids, modern cultivars, etc.).	
<b>Note:</b> Descriptors 14 to 16 below should be completed accordingly only if it was 'collected'.	
<b>14. Location of collecting site</b>	<b>(COLLSITE)</b>
Location information below the country level that describes where the accession was collected, preferable in English. This might include the distance in kilometres and direction from the nearest town, village or map grid reference point, (e.g. 7 km south of Curitiba in the state of Parana).	
<b>15. Geographical coordinates</b>	
<ul style="list-style-type: none"> <li>• For latitude and longitude descriptors, two alternative formats are proposed, but the one reported by the collecting mission should be used</li> <li>• Latitude and longitude in decimal degree format with a precision of four decimal places corresponds to approximately 10 m at the Equator and describes the point-radius representation of the location, along with Geodetic datum and Coordinate uncertainty in metres.</li> </ul>	

**Note:** The following two mutually exclusive formats can be used for latitude:

<b>15.1 Latitude of collecting site</b> (Decimal degrees format) <b>(DECLATITUDE)</b> Latitude expressed in decimal degrees. Positive values are North of the Equator; negative values are South of the Equator (e.g. -44.6975).
<b>15.2 Latitude of collecting site</b> (Degrees, Minutes, Seconds format) <b>(LATITUDE)</b> Degrees (2 digits) minutes (2 digits), and seconds (2 digits) followed by N (North) or S (South) (e.g. 103020S). Every missing digit (minutes or seconds) should be indicated with a hyphen. Leading zeros are required (e.g. 10---S; 011530N; 4531--S).

**Note:** The following two mutually exclusive formats can be used for longitude:

<b>15.3 Longitude of collecting site</b> (Decimal degrees format) <b>(DECLONGITUDE)</b> Longitude expressed in decimal degrees. Positive values are East of the Greenwich Meridian; negative values are West of the Greenwich Meridian (e.g. +120.9123).
<b>15.4 Longitude of collecting site</b> (Degrees, Minutes, Seconds format) <b>(LONGITUDE)</b> Degrees (3 digits), minutes (2 digits), and seconds (2 digits) followed by E (East) or W (West) (e.g. 0762510W). Every missing digit (minutes or seconds) should be indicated with a hyphen. Leading zeros are required (e.g. 076---W).
<b>15.5 Coordinate uncertainty [m]</b> <b>(COORDUNCERT)</b> Uncertainty associated with the coordinates in metres. Leave the value empty if the uncertainty is unknown.
<b>15.6 Coordinate datum</b> <b>(COORDDATUM)</b> The geodetic datum or spatial reference system upon which the coordinates given in decimal latitude and decimal longitude are based (e.g. WGS84, ETRS89, NAD83). The GPS uses the WGS84 datum.
<b>15.7 Georeferencing method</b> <b>(GEOREFMETH)</b> The georeferencing method used (GPS, determined from map, gazetteer, or estimated using software). Leave the value empty if georeferencing method is not known.
<b>16. Elevation of collecting site [masl]</b> <b>(ELEVATION)</b> Elevation of collecting site expressed in metres above sea level. Negative values are allowed.
<b>17. Collecting date of sample [YYYYMMDD]</b> <b>(COLLDATE)</b> Collecting date of the sample, where YYYY is the year, MM is the month and DD is the day. Missing data (MM or DD) should be indicated with hyphens or '00' [double zero].
<b>18. Breeding institute code</b> <b>(BREDCODE)</b> FAO WIEWS code of the institute that has bred the material. If the holding institute has bred the material, the breeding institute code (BREDCODE) should be the same as the holding institute code (INSTCODE). Follows INSTCODE standard. Multiple values are separated by a semicolon without space.
<b>18.1 Breeding institute name</b> <b>(BREDNAME)</b> Name of the institute (or person) that bred the material. This descriptor should be used only if BREDCODE cannot be filled because the FAO WIEWS code for this institute is not available. Multiple names are separated by a semicolon without space.

**19. Biological status of accession****(SAMPSTAT)**

The coding scheme proposed can be used at 3 different levels of detail: either by using the general codes (in boldface) such as 100, 200, 300, 400, or by using the more specific codes such as 110, 120, etc.

## ANNEX I

### List of major changes in MCPD V.2 (2012)

The revision process to update the FAO/IPGRI List of Multi-Crop Passport Descriptors (MCPD, 2001), has involved consultation with more than 300 people from 187 institutions in 87 countries.

The review process indicated that: (a) there were no major concerns with the 2001 version, thereby supporting its validity; (b) some additional flexibility with existing descriptors was considered necessary; and (c) a few new descriptors could enhance the MCPD. All these amendments are listed below.

#### *List of major changes in MCPD V.2 (2012) compared with the 2001 version:*

##### Title

It now reads FAO/Bioversity (formerly FAO/IPGRI) to reflect the name change to Bioversity International.

##### Introduction

Text related to this updated version was amended reflecting main changes, including addition of this historical list of changes, as an Annex.

##### Common formatting rules

- Explanation of coding schemes related to new descriptors is provided to assist in the computerized exchange of data.
- **Country names:** New ISO Country codes Web link is provided, along with a Web link for obsolete codes (e.g. SUN, DDR).
- **FAO WIEWS Institute codes:** The Web link for the current set of institute codes has been updated. A link is provided to an electronic form for generating new institute codes online.
- **Missing data:** For those descriptors related to 'Dates', missing data can be indicated with hyphens or '00'[double zero] to ensure consistent data transfer whatever system is used.
- **Latitude and longitude:** Two formats (Latitude: DDMMSSH or +/-DD.DDDD; Longitude: DDDMMSSE/W or +/-DDD.DDDD) are allowed, but only one of the two coordinate formats should be used (the one that was reported by the collecting mission).

**OPEN QUESTION**

**Global unique identifier**

A global unique identifier or persistent identifier (GUID) such as the Digital Object Identifier (DOI), or the Life Science Identifier (LSID), would be useful to build automatic services that integrate germplasm data and would enable the linkage required to identify accessions and other genotype entities across different information systems.

The topic was raised by a few respondents in the survey for this revision, but further international consultation would be needed to provide a consensus.
